

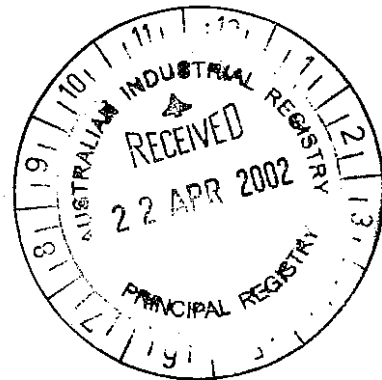



5. The accounts, statements and audit report were prepared and provided to members prior to the General Meeting of members of the Association held on 12 November 2001 and are contained in annexure 1 to this statutory declaration, being the Clubs Victoria Inc. Annual Report.
6. The attached list is a correct statement of information of persons holding office in Clubs Victoria Incorporated as required by s268(1)(c). An election was held on 12 October 2001 and the persons holding office correctly reflects the outcome of that election, with the exception of Leon Wiegard who was appointed to a vacancy in accordance with the rules.
7. An election will be held not more than three months nor less than one month prior to the Annual General Meeting to be held during the period August to November 2002. A record of such election will be duly made as required by s268(1)(d) of the Act and regulation 102(c).

I make this solemn declaration by virtue of the *Statutory Declarations Act 1959* as amended and subject to the penalties provided by that Act for the making of false statements in statutory declarations, conscientiously believing the statements contained in this declaration to be true in every particular.


