The number of positions for the Secretary is set out in Rule 35B and the number of positions is one (1).

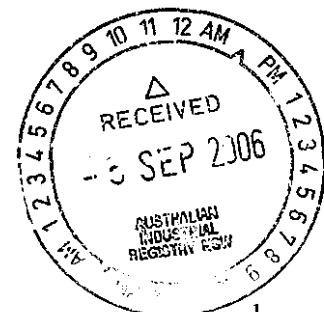
The number of positions for the Councillors and Alternate Councillors for each Division is set out in Rule 29(2) of the Constitution and varies in accordance with the number of members in each Division.

- The Executive Board is the second stage of a collegiate voting system.


The reason for the election is that the term of office for the Office Holders is due to expire at the Associations AGM, which is expected to be held in March 2007.
