PRESCRIBED INFORMATION FOR THE CONDUCT OF AN ELECTION

Pursuant to Section 189 and Regulation 138 of Schedule 1 of the Workplace Relations Act 1996 ("the Act"), I inform you of the following prescribed information:

- (a) An election is required in respect of each of the following offices:
 - President
 - Vice President
 - Treasurer
 - Other members of the Executive Committee (6 positions)
 - Chief Executive
- (b) The election is required as the term of office for each of the positions will shortly expire.
- (c) All members of the NSW Farmers' (Industrial) Association are eligible to vote.
- (d) The next Annual General Meeting of members of the Association will be held at 5 PM on Thursday 20 July 2006 at Hall 4B Sydney Showground Homebush Bay, Sydney, to enable members present to nominate candidates for the offices listed in item (a).

Rules 22(i) (Nomination – President, Vice President, Treasurer), 23(ii) (Nomination – Executive Committee), 25 (i) (Nomination – Chief Executive) and 36(i) (Nominations at Annual General Meeting) provide nominations of

candidates for the offices referred to therein to be made at the Annual General Meeting.


(e) A direct voting system is to be employed in the conduct of the election.
