### **Board Members**



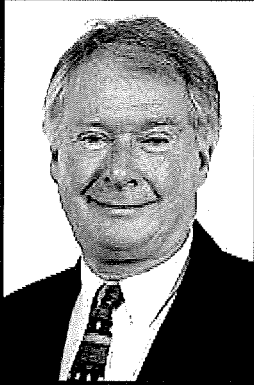
