Date of registration: 3 May 2010

The organisation was previously a transitionally recognised association.

The management of the affairs of the organisation is vested in the Board, which comprises ordinary Board members and the Office Bearers of the organisation.

Board members are elected for a term of 4 years, while the Office Bearers are elected for a term of 2 years. The organisation's elections are conducted by the Australian Electoral Commission.
