The governance of the organisation is vested in the Union Council, consisting of representatives from each division. The organisation is also governed by a Union Executive comprising the Office Bearers of the organisation. Each division is governed by a Division Conference and Division Executive.

All office positions are elected for a term of 4 years. The organisation's elections are conducted by the Australian Electoral Commission.
